Rights and Responsibilities Summary Exit Counseling

Obtaining a loan is a serious legal obligation. Therefore, it is extremely important that you understand your rights and responsibilities and agree to honor them.

I understand that I have a right to the following:

- Written information concerning my loan obligations and information on my rights and responsibilities as a borrower
- A grace period and an explanation of what this means
- A repayment statement that includes information about the balance I owe, the minimum payment amount required each month, and the number of payments
- Information concerning available deferments, cancellations, and forbearance
- Prepayment of my loan, in whole or in part, without an early-repayment penalty
- A copy of my promissory note either before or at the time my loan is disbursed

I understand I am responsible for:

- Completing exit counseling before I leave school or drop below half-time enrollment, including submitting a completed Personal Data Sheet
- Repaying my loan in accordance with my repayment schedule
- Repaying my loan even if I do not complete my academic program, I am dissatisfied with the education I received, or I am unable to find employment after I graduate
- Notifying the MU Student Loan Repayment Center and my other lenders if I:
 - Move/change my address or telephone number
 - Change my name
 - Change my Social Security Number
- Making monthly payments on my loan after my grace period ends, unless I have a deferment or a forbearance
- Notifying the MU Student Loan Repayment Center of anything that might alter my eligibility for an existing deferment or forbearance
- Making payments on a monthly basis. Late payments will result in a late charge being assessed per month per loan. *All loans are reported monthly to a national credit bureau.* If I want a payment to be applied in a special way, I must send that payment to 14 Jesse Hall with a note explaining how I wish the payment to be applied. All payments not otherwise noted will be applied to the amounts billed with any remainder being applied to principal (not to any future payments). Any payments returned unpaid will result in a \$20.00 fee being assessed.
- Notifying the MU Student Loan Repayment Center if I am unable to make a scheduled payment
- Paying all costs of collection (including collection agency charges and litigation costs) if I do not pay my loan as set forth by my repayment schedule.

I have read and I understand my rights and responsibilities as a borrower. I understand that I have a loan or loans that must be repaid.
